1997 promises to be even busier, because of ever greater challenges

being faced by Rooi Els. There is creeping commercialism which is in opposition to the Rooi Els Vision and which threatens to destroy the unique character of our village, the impact of day visitors on Rooi Els and the handling thereof, the onslaught on sea life, the problems surrounding the entrance to the village, drawing up a structure plan for the nature reserve as well as a fire-fighting plan, to name only a few.

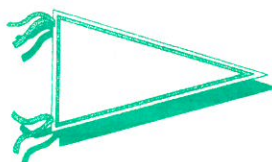

ERELEDE

Vir die eerste keer in die geskiedenis van die REBBV is twee lede as *lewenslange erelede* voorgestel en tydens die AJV is oom Skakel Kriek en Dr Dennis Cowen eenparig aangewys. Die volgende lewensketse oor hulle is opgestel:



OOM SKAKEL

is op 20 Februarie 1905 op die plaas Maarman naby Fouriesburg gebore.

Hy was een van 12 kinders. Die Kriek-kinders was tot 10-jarige ouderdom op 'n plaasskooltjie en daarna moes hulle te voet, te perd, per ossewa of fiets, na die dorpskooltjie op Fouriesburg gaan.

Oom Skakel behaal die grade B.A. -tale met Grieks en Hebreeus, en e M.A. in Afrikaans-Nederlands aan die Grey Universiteitskollege en tot die einde van sy studies dra hy selfgemaakte velskoene. Deur

bemiddeling van D.F. Malherbe, van Hans-die-Skipper-faam, het hy verslaggewer van Die Volksblad geword en vorder tot assistent-redakteur.

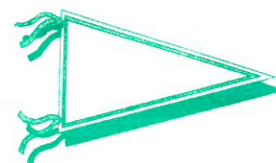
In 1955 verhuis sy gesin, wat uit sy vrou Freda en die drie dogters bestaan, na Kaapstad waar hy redakteur van Die Landbou-weekblad word.

Na sy aftrede begin hy by Die Burger werk en na 64 jaar as joernalis tree hy finaal uit. Op 75 raak oom Skakel rekenaargeletterd!

In 1957 koop hy 'n erf op Rooiels vir £83 en later nog 'n erf vir £300. Op die een bou hy 'n motorhuis en op die ander 'n woonhuis wat hom in 1971 R6 000 kos.

In die vroeë sewentigerjare stig hy saam met Pieter Fourie, die dramaturg, en 'n eiendomsagent, Carlos Sabbe, die eerste Rooiels Belastingbetalersvereniging en is hy dan ook die eerste voorsitter.

Sedertdien veg hy verbete om Rooiels so ongeskonde as moontlik vir ons te hou.



Professor Denis Victor Cowen

Lawyer, legal philosopher and writer, Denis Cowen, is now rising 80. For more than 50 years, he has served his profession and the wider general public, while successfully pursuing several different but complementary careers. Thus:

* From mid-1945 to the end of 1961 he was a well-known professor of law in the UCT, being

Dean of the Faculty and a member of the UCT's Council for several terms;

* For some six years, from 1962, he was a professor of law and Director of Legal Research in the University of Chicago;

* For some twenty years he was the constitutional adviser first to the Government of Basutoland (as it was when he began work there) and then to successive Governments of Lesotho, continuing his work there into the late 1960's until after that country's independence;

* From 1970 until 1980 he was the Chief Legal Adviser to the Johannesburg City Council, specialising in environmental and town-planning issues;

Prof. Cowen first acquired an international legal reputation with his publications on, and involvement in, the constitutional crises of the early 50's concerning Parliamentary Sovereignty. He is the author of several books and of many papers in learned journals. He is currently Chairman of the Rooi Els Court-Order Water Monitoring Committee; and was recently elected - together with Prof Andre Rabie of US and Judge Mark Kumleben - an Honorary Life Member of the South African Environmental Law Association.

Dennis Cowen's interests and achievements go well beyond the law - and embrace literature, history, philosophy and his great love for Rooi Els, which he has served for many years on different levels.

- Die Hackkomitee bestaan uit die volgende persone: Jean Cowen, Anula Scholtz, Berdie Volgraaf, Elida van Dyk en Kay Cooper. Hulle voorsien dat daar in die toekoms elke eerste Saterdag van die maand 'n kapdag sal wees.
- The hack committee in conjunction with the Wild Life Society of Somerset West will jointly host a hack on the small holdings south of Rooi Els on Easter Monday.
- Ene mnr Stormberg, wat moontlik 'n voorstel het oor

spoedbulte vir grondpaaië, gaan gevra word om sy voorstelle op skrif te plaas en moontlik die oorgangsraad hieroor toe te spreek. Rooiels se spoed- en parkeerprobleem moet nou as 'n saak van dringendheid gesien word.

- The Boatclub AGM will be held on Easter Saturday from 11:00 to 13:00 at erf 101. The problems experienced at the slipway and in the bay during the season will be discussed at the AGM.

Bird

Chat



We concentrated our last Bird Chat on nesting as Rooi Els offers such splendid variety. You may have noticed the weather patterns are altering and "summer" started much later - so, too, did the nesting activities. Many birds are now raising second broods, an indication of plentiful food supplies and contentment in their surroundings.

In our own garden the first broods, now teenagers, are learning the art of fending for themselves. Like their human counterparts some teenagers are more reluctant to leave home than others! Close observation of certain species also reveals that the young have to be "educated" (No Bengu cuts in the bird world!) concerning what to eat, how to catch it, etc. This also depends upon the type of chick. Some are able to fend for themselves, are feathered and mobile immediately after hatching (PRECOCIAL), e.g.

Whitefronted Sandplovers (Vaalstrandkiewiet), others are helpless and totally dependent on their parents (ALTICIAL), e.g. Cape Robins (Gewone Janfrederik) or Cape Bulbuls (Kaapse Tiptol). The very best place to observe birds is your own backyard. Ironically, it's the most common species that are neglected and surprisingly little is known about some of them.

Food and water will encourage birds into your garden. In our own garden the Cape Francolin (Kaapse Fisant) is at "home" until breeding time when it disappears into the wilder areas of Rooi Els, returning with its surviving youngsters for the corn handouts at a later date. The same is true of "our" Yellow rumped Widow (Kaapse Flap). Both have become very tame, the latter knocking on the patio window when the seeds run out! On one occasion we found his mate doing tight circuits of the lounge when the door had been left open. Our resident robins are also inquisitive and will spend time investigating the garage and stoep when doors are left open. They are also very particular about fresh water for bathing in. More than once we've had reproachful looks when the bird bath is not up to scratch.

We've spoilt our Greater striped Swallows (Grootstreepswael) who came

looking for cottonwool handouts for nest linings. Fruit trimmings bring frenzied activity from mousebirds (Gevlekte Muisvoëls) and bulbuls and a chance to observe them at close quarters. Our open stoep takes on aviary proportions in inclement weather. We count ourselves very fortunate.

Watch out for rare glamorous summer visitors like the European Bee Eater (Europese Byvreter) and our less common residents such as the Paradise Flycatcher (Paradysvlieëvanger).

UPGRADING OF ROOI ELS ENTRANCE AREA

APPROXIMATELY 6 METERS. COST: APPROXIMATELY R40,000. IT SHOULD BE NOTED THAT HEAVY VEHICLES TURNING ON THIS MAY WELL DAMAGE THE SURFACE. (IMPLICATIONS ON RATES: ALREADY ABSORBED)

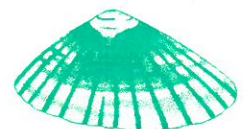
OPTION 2:

TO TAR THE ENTRANCE AREA PROPERLY WITH 40 MM ASPHALT TO A WIDTH OF 8 METERS WITH A PAVED PARKING AREA (USING 60 MM PRECAST BLOCKS) ON THE EXISTING SHOP SIDE, TO ALLOW FOR TURNING. COST: APPROXIMATELY R180,000. (IMPLICATIONS ON 97/98 RATES: 16,5%)

OPTION 3:

TO BLOCK PAVE THE WHOLE AREA (LENGTH OF ROAD - 80M; WIDTH OF ROAD - 8M; PARKING WIDTH - 5,5 M FOR A LENGTH OF 50M) AND ALLOW FOR STORMWATER DRAINAGE. COST: APPROXIMATELY R250,000. (IMPLICATIONS ON 97/98 RATES: 24%)

- 96 people lodged objections to the removal of a title restriction on Erf 324 enabling its subdivision. A further 116 people signed a petition against the proposed subdivision.

A Fynbos

Garden



This year, because of the long, wet spring, the pincushions (*leucospermum cordifolium* and *leucospermum conoparpodendrum* or kreupelhout) had a long flowering season, and the protea obtusifolia which usually flowers in February and March, produced a rosy bloom a couple of months early, just in time to be the centrepiece in a posy for a friend on her birthday on Old Year's Eve. At Rooi Els the colours, white, pink, purple and deep red, characterise the months of late summer and autumn. Already the elegant cone-shaped spikes of small erica are glowing purple, and soon there will be festive processions of

the pink and white Prince of Wales heath dancing along the banks of the streams on the smallholdings. I have not yet succeeded in growing this lovely erica, but plan to lead the water from the roof to create a damper area in which I hope it will flourish. It is time to think of buying plants to make the best use of the coming wet season. The Kirstenbosch sale of indigenous plants takes place at Kirstenbosch on 15 March. I go early, armed with a list of plants indigenous to our area, and boxes and baskets, as well as someone to help with the carrying. Unless it is possible to water the plants by hand, it is best to wait until the rains are imminent before planting them out. Most of those we have planted, survive. We throw handfuls of leaf mulch found in the garden into the holes dug for the plants, and water the holes before putting in the plants as firmly as possible. We make a mulch of small stones around the roots, and then create a windbreak with large stones, which we will keep in place for two or three years. Extra watering may be necessary for two summers after planting, and a few handfuls of leaves scattered over the stone mulch, will protect the plants from becoming too hot on scorching summer days.

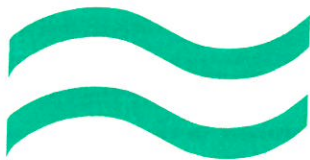
The red glow of the *Erica Mammosa* used to be a common sight along the roadsides at Rooi Els. We have planted several over the past few years - not only the red variety, but also soft purple and white - and are now watching the flower buds swelling on the branchlets in preparation for a long and colourful flowering season.

Brand van die Natuurreservaat

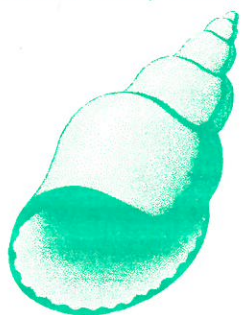

Otters

Een van ons streek se vele aantreklikhede is 'n dier wat selde gesien word, naamlik die otter (*Aonyx capensis*). Otters is betreklik groot diere met 'n massa van tot 15 kg, maar word baie min gesien omdat hulle sku is en meestal saans en soggens vroeg aktief is. As 'n mens egter iets van hulle gewoontes weet en mooi kyk, sal jy wel 'n otter raakloop.

Die eerste teken van otters wat 'n mens gewoonlik gewaar, is hulle mis. Otters mis op een plek en die mishope word nie weggesteek nie. Die vars mis het 'n kenmerkende skerp reuk wat dadelik die aandag trek. Die mis is ook maklik herkenbaar omdat dit hoofsaaklik uit krapdoppe en visgrate bestaan. Spore in die omgewing van die mishope gee verdere aanduidings van otters se teenwoordigheid. Die spore is kenmerkend omdat otters nie kloue het nie - vandaar dan ook die Engelse benaming, "Cape clawless otter".

In ons omgewing is daar meer kos vir otters in die see as in die riviere en hulle jag gevolglik meestal in die see. Omdat hulle egter hulle pelse in vars water moet afspoel, is die beste plek om vir hul tekens te soek daar waar 'n stroompie in die see loop.

As daar vars mis en spore in die omgewing is en jy die otters graag wil sien, moet jy vroeg opstaan en geduldig wees. Otters is gewoonlik vroegoggend van vieruur tot sesuur en saans van ongeveer sesuur tot tienuur, aktief. Hulle beweeg vinnig van hul skuilplekke na die see, maar wanneer hulle uit die see kom, bad hulle eers in die vars water, rol in die sand en bak dan droog in die son. Die beste manier om hulle te sien,

is dus om 'n uitkykpunt te soek, voor sonop stelling in te neem en geduldig te wag. Dit verg wel 'n bietjie moeite, maar om hierdie skugter diere waar te neem, kan net so opwindend wees soos om 'n leeu in die wildtuin te sien - en dit hier in jou eie agterplaas!

Selfs sonder om die otters self te sien, kan ons tog baie van hulle te wete kom uit die tekens wat hulle laat. Die mis wat normaalweg uit krap-en-kreefdioppe, visgrate en beentjies van paddas en voëls bestaan, gee 'n duidelike aanduiding van hulle dieet. Onderzoek toon dat hul kos hoofsaaklik uit die see kom, maar langs riviere en veral tydens stormweer, kom daar ook reste van rivierkrappe en paddas in die mis voor.

Die mishope dien om hul gebied af te baken. Hieruit, en van die spore, kan afgelei word hoeveel otters daar in 'n gebied is. Volgens my eie waarnemings vergelyk die digtheid van ons streek se otterbevolking goed met dié van die Tsitsikamma Nasionale Park, 'n gebied met baie min versteuring.

Otters word wêreldwyd as 'n goeie teken van 'n onversteurde omgewing beskou. Hulle is skugter diere

wat gevoelig is vir die druk van mense en vir die oorbenuiting en besoedeling van die omgewing - iets wat al feitlik sinoniem geword het met elke menslike nedersetting.

Dat otters nog vry algemeen in hierdie streek voorkom, is 'n aanduiding daarvan dat ons omgewing nog betreklik "gesond" is. Ver al die beskerming van die kusstrook met sy baie digte bosse wat skuiling bied, is belangrik. Otters het egter 'n wye loopgebied en 'n gesonde bevolking sal uiteindelik afhang van hulle veiligheid in die groter omringende gebied. Die beplanning van die kusstrook van Botrivier tot by Rooiels kan gerus die voortbestaan van otters as vertrekpunt gebruik. As die otters gelukkig is, kan 'n aangename omgewing gewaarborg word.

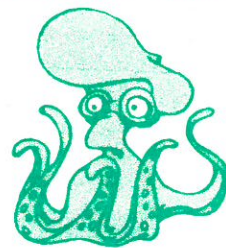

Rehabilitation of the Reservoir-area and MTN site

Construction at the above site resulted in an open scar on the hillside approximately 120 meters long and 26 meters wide at the widest point. The most challenging feature which required rehabilitation was the 1 - 1.5 m vertical cutface on the

uphill side of the access road. The balance of the rehabilitation work involved a more moderate slope (45degrees) comprising loose sandstone gravel.

The objectives of the project were to improve the visual impact by covering or "hiding" the exposed rocky cutface and to revegetate the site with locally indigenous fynbos vegetation and so to improve the negative visual impact of the scar.

The first phase of the project has been to cover the cutface by establishing a cut brush and branch layer against it. This layer is held against the slope with wire mesh pinned into the slope with steel rods. In order to improve the substrate of the 45 degree slope, simple horizontal gabions were built on the contours of the slope in order to hold enriched soil.

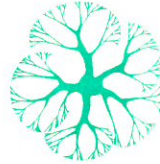
The second phase will involve bringing in topsoil and planting with suitable plant material. This will be done after the arrival of the first good winter rains.

The road has been levelled and a turning circle marked out. All the rest of the road verges will be planted up and well mulched.

Hopefully, within a few years the scar will be much less visible.

Die luiperd is in 'n vanghok vasgetrek en in die Kogelberg losgelaat. Verlede Saterdag het nog 'n luiperd, of dieselfde een wat teruggekom het, op Rooiels 'n miniatuur poedel gegryp en laat vat bosse toe.

Ek sou wat wou gee om 'n luiperd in my tuin te hê. Ongelukkig is daar mense wat histories raak as hulle 'n muis, 'n spinnekop, 'n slang, 'n bobbejaan of 'n wildekat sien, om van 'n luiperd nie te praat nie. Al hierdie mooi diere van die veld word mos onder "ongediertes" geklassifiseer.

HUL SPORE

Hoe dikwels het ek nie in die berg in 'n voetpaadjie gestap en 'n uur later teruggekom en die spore van 'n luiperd gesien wat my gevolg het nie.

Maar hom onder oë kry, moenie glo nie. In die Sederberge het ek in 'n droë rivierloop geslaap. Die volgende oggend was 'n luiperdspoor langs die

plek waar ek met my kop geleê het. Hy moes diê nag aan my geruik het.

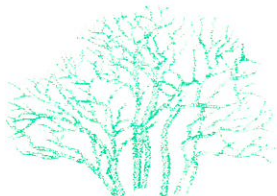

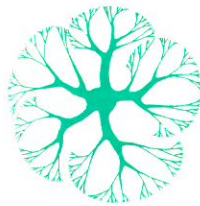

Waste Management



The disposal of solid waste in our region, as well as the Greater Hermanus and Bot River areas is in a crisis situation. All four existing waste sites are unsightly, general difficult to manage and pose a serious threat to the environment.

The Department of Water Affairs insists that the waste disposal sites at both Betty's Bay and Kleinmond be closed as a matter of urgency. Our Council has not yet succeeded in finding an alternative site within our area, and the solution may well be a site outside the Hangklip-Kleinmond area.

This is an expensive solution, and it is therefore of the utmost importance that as a community we reduce the amount of waste that must be transported out of the area as much as possible. The Council has appointed Dr Neil Fairall as a consultant to advise on recycling and the Exco of the RERA will also be seeking advice as to how to face this challenge in Rooi Els. Any input from ratepayers would be welcome.
