

## A FYNBOS GARDEN: NEW PLANTS FOR OLD

Some of us wish that a fire could magically sweep through our gardens at Rooi-Els, leaving of course all buildings unscathed, but destroying the old woody bush, the dodder that is strangling too many plants and unwanted grasses. If we and our buildings were not around, this is how nature would deal with the problem.

Instead, following advice from a botanist, we clear away the woody bush in patches, burn it in our braai and return the ashes to the garden. It is interesting to work with the secateurs, cutting away the old growth which is likely to catch fire if only a match is thrown into it. Underneath each bush lies a thick mulch of dropped leaves and the bark of over twenty years' growth. Sometimes the pathways of small mammals are clearly discernible. We use some of the mulch to fertilish the holes into which we put plants indigenous to the area, bought from a nursery. But we leave most on the ground, and when the rains come, seedlings and bulbs begin to grow through. A year or so later clumps of restos with their heads of shining seeds are dancing in the varied winds of Rooi-Els, and ericas we thought had almost disappeared from our erf, are back in abundance.

We have found that it is important to disturb the soil as little as possible. The wealth of seeds and bulbs in our soil seem only to be waiting for light and air and water, and the help of birds, insects and small mammals, to come forth in abundant variety and beauty.

Met teleurstelling het ons verneem dat die Stadsraad daarna sy vuurwapen afgeneem het. Intussen is dit weer aan hom terugbesorg, maar 'n ondersoek is hangende. Die Rooiels Belastingbetalersvereniging wil graag ons steun aan Craig toesê wat met entoesiasme en ywer bewaringsake op die hart dra.

Rooiels-inwoners kan met reg ongelukkig voel oor die nuwe verhoging in erfbelasting. Tesame daar gemiddeld 'n 107% styging oor die afgelope twee jaar, terwyl daar maar min addisionele dienste gelewer word. Julia Aalbers is besig om ernstige aandag aan hierdie saak te skenk. 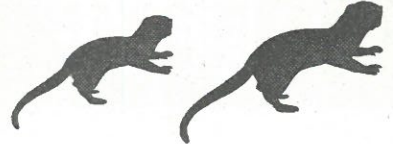

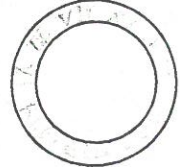
1 Begroting: Julie 96/Julie 97

Hier bestaan daar steeds probleme, alhoewel die begroting tog na ure van debatering, argumente en pleit goedgekeur is. Die probleme het, myns insiens, ontstaan a.g.v. 'n verouderde benadering waarvolgens daar afsonderlik vir Rooiels, Pringlebaai en Betty'sbaai begroot en belas word. So gebeur dit dan dat ons uitgawes alles teen die 318 belasbare erwe in Rooiels verhaal moet word tesame met met toegeysde oorhoofse kostes. My houding is dat ons 'n eenvormige belastingstruktuur moet hê vir die Hangklip gebied wat nie, soos Kleinmond, teerstrate, biblioteke en skole het nie. (Die sogenaamde buite-gebiede/ plattelandse areas!)

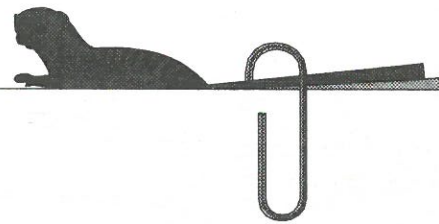
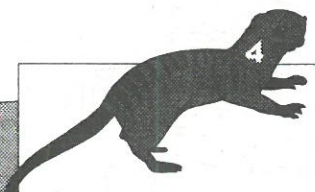
Stygende belasting kan buite beheer raak. Ek en die Belastingbetaletersvereniging is besig om opnuut hierna te kyk vir die nuwe begroting (97/98) en is vasberade om nie weer so 'n verhoging toe te laat nie.

2 Waterstelsel vir Rooiels

Inwoners sal bly wees om te verneem dat 'n verdere reservoir vir Rooiels nie nodig is nie. Ons kan aan groeiende behoeftes voorsien tot die jaar 2010 indien ons die huidige reservoir beter benut deur 'n addisionele pomp aan die toevoerpyp aan te bring. Dit, tesame met die verbeterings aan die algehele watersuiweringstelsel en die aanbring van addisionele opgaarfasiliteite vir gesuiwerde water by die suiweringsaanleg, sal in die 96/97 boekjaar uitgevoer word.

### 5 Rooiels - Gordon's Bay Road

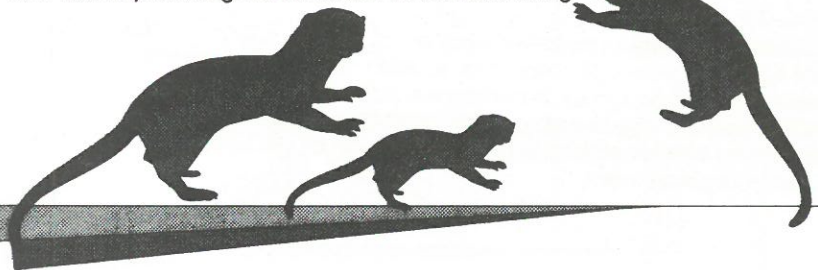
Critical of the RDP ? We suggest you take time-out and talk to the engineers on the Rooiels-Gordon's Bay road where some 120 unskilled people are being trained in road-making techniques - labour-intensive techniques of gabion-making, pipe-laying, constructing curbstones and building walls of natural stone.

Also of great importance to Rooielsers is Mr James Wilkinson's (of the project engineers Jeffares & Green) assurance that both lanes, full width, whole length, will be open for the period 15 December 1996 to 7 January 1997, although obviously the job won't be completed by then.

Your ratepayers exco arranged a meeting and an on sight inspection with the engineers and other representatives on 1 June and discussed various aspects of the contract. We were impressed with the helpful attitude of all concerned.

At the moment, we have two robots on the road. In August there will be a third when they start on the refurbishment of the Steenbras River bridge and a fourth at Kogelbaai. Also in August, heavy equipment will start moving in to tar the completed sections, starting from Rooiels.

At a mid-July meeting held at Rosie's there was a strong



contingent representing police and traffic police. The station commander at Gordon's Bay, Insp. Freddie Vermeulen, confirms that they are watching developments closely and intend having a special patrol on the road during the summer season.

According to the contractors, Grinaker Civils,

*"It is a requirement of the contract that the sections under construction must be separated by gaps of at least two kilometers to facilitate traffic flow. Four teams of locally recruited labour have been trained in various skills and are presently constructing subsoil drains, masonry retaining walls and stone packed abion walls. A further two teams are currently being trained and it is expected that by the end of the year approximately 150 previously unskilled and unemployed workers from the local communities will be employed on the project after having been recruited and trained.*

*As the road traverses a very environmentally sensitive area, a full-time Environmental Control Officer, Ms Megan Anderson, has been appointed to advise and educate the construction team on all environmental matters and to monitor construction activities. An environmental management plan has been compiled in accordance with the contract conditions. This deals with items such as control of litter, prohibition of open fires, fire-fighting procedures, provision of toilet facilities and prevention of water pollution."*

## UIT DIE BURGER - 15 JAAR GELEDE

Hierdie berig het 15 jaar gelede in Die Burger se gewilde rubriek Van Alle Kante verskyn:

### WOESTE GEVEG VAN ROOIELS

Keeromstraat 30, Kaapstad, 1 Mei 1981

Enkele dae gelede het ons gevra of iemand die geskiedenis ken van die plaasnaam Barends Eerendood, naby Riversdal, wat later tot Windsor verdoop is. Ons het die storie gekry, danksy die bemoeienis van kerkargivaris, ds Charles Hopkins, en mnrSaayman van Hermanus. Die verhaal van hoe die plaas sy naam Barends Eerendood gekry het, klink soos 'n sprokie. Die storie begin heel dramaties.

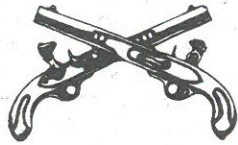
Dit is Februarie van die jaar 1805. Die Kaapse Korps het toe al bestaan - hul basis was Wynberg. Wat verkeerd gegaan het en wat die oorsaak van die bittere ontevredenheid onder die pandoere was, soos hulle toe bekend was, weet ons nie. Maar 'n stuk of 30 van hulle gryp hul gewere en ammunisie en laat vat oor die Kaapse Vlakte, in die rigting van die Hottentots-Hollandkloof.





Hulle trek tot by Rooiels, waar hulle in die grot gaan skuil wat later as die Drostersnes bekend sou staan.

Goewerneur J W Janssens van die Kaap laat dadelik kompanies van Stellenbosch en Swellendam oproep om die drosters te gaan haal. 'n Hewige geveg moes gevolg het want een burger, Barend Saayman, nog nie 20 jaar oud nie, sneuwel in die geveg. Die geveg het op 7 Februarie 1805 plaasgevind.



### GESKENK

Hoeveel pandoere dood is, weet ons nie. Wat wel bekend is, is dat 'n aantal gevange geneem is. Volgens oorlewering wou die pandoere hulle nie oorgee nie (gedagtig aan die straf wat wag?), tot hul drie korporaals doodgeskiet is en toe het die oorlewendes van die oorspronklike groep soldate glo die gewere neergegooi.

Goewerneur Janssens het tydens sy bewind geprobeer om 'n militêre bewusheid by die burgers van die Kaap te kweek. Hy het nooit 'n kans laat verbygaan om militêre parades te hou, medaljes uit te deel en helde te vereer nie.

Dit het hy ook nou gedoen. Onmiddellik na die geveg teen die pandoere het hy 'n plaas waarop die gesneuwelde burger se ouers gewoon het, vry van rekognisie-geld ('n vorm van jaarlikse belasting) aan Barend se ouers geskenk.

Goewerneur Janssens het self die plaas die naam Barend Saaymans Eerendood gegee. In die omgangstaal het die plaas later Barends Eerendood geword. Jare later is die plaas toe Windsor herdoop.

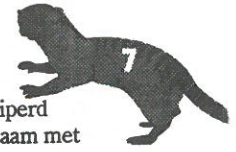
Die plaas lê naby Riversdal. As 'n mens anderkant Riversdal met die Stilbaaipad afdraai, ry jy so 'n halwe kilometer en dan draai jy weer regs af. So ses kilometer verder en jy is op Barends Eerendood oftewel Windsor.

### BROOD GESTEEL

Hierdie rubriekskrywer het lank gelede in die Koeëlberge gaan stap en die nag in die Drostersnes geslaap. Hy het nie die grot se grieselige geskiedenis geken nie en het heel rustig geslaap. Geen spoeke nie. In die nag het 'n geritsel by sy rugsak hom laat wakker word.

Die volgende môre was 'n hele bruinbrood weg. Wat kan 'n bruinbrood wegdra? Daar is hondmak muishondjies wat helder oordag broodkorsies kom optel het wat ons daar neergegooi het. Maar 'n muishond kan mos nie 'n hele brood dra nie. Wegsleep, ja. Miskien was ons baie moeg en het só vas geslaap dat ons dit nie agtergekom het nie. In die kloof was ook baie bobbejane wat die nag vreeslik gelawaai het. Maar bobbejane soek nie in die nag kos nie.

### LUIPERDS



Daardie omgewing is ook bekend vir sy luiperds, maar ons het nog nooit van 'n luiperd gehoor wat brood eet nie. 'n Tydjie nadat ons daar geslaap het, het 'n dogtertjie saam met haar ouers in die kloof opgestap. Die dogtertjie het op 'n pragtige luiperdwelpie afgekom.

Sy het die dingetjie opgetel en toe storm die luiperdwyfie uit die bosse, gee die dogtertjie 'n oorveeg, gryp haar welpie en laat spat. Die dogtertjie het steke in die wang gekry waar die luiperd se alterp naels dit oopgeskeur het.

'n Gordonsbaaise konstabel het van die voorval gehoor en 'n jaggeneskap georganiseer om die luiperd te soek. Hulle is met honde die berg in, maar van luiperds het hulle geen teken gekry nie.

### MORSDOOD

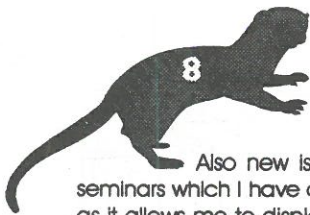

### DUNE MANAGEMENT

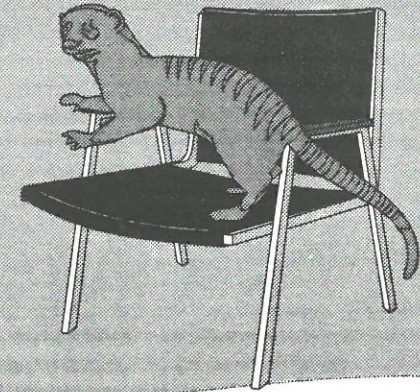
July and August are traditionally the worst months in the Cape and, as if we needed more convincing after summer, Rooi-Els endures further magnificent winter displays of Mother Nature's awesome power. This year the small beach has lost up to half a metre of sand at its west end and exposed rocks that last saw the light of day many years ago, while the east facing dune has been eroded massively. However, our practice of using the offcuts from rootkrans and part jackson hacks has been very successful in stabilising and promoting growth of grasses on the north facing dunes. The dune above the river has also been stabilised with some success with the pleasing consequence of it being well grassed again. We will seek some professional advice on stabilising the east facing dune and would appeal to residents to encourage their children or visitors to keep to existing paths around the dunes.

### STRANDESTUUR

### CONTRIBUTION FROM THE CHAIR



As you will gather from the various portfolio reports, your Committee has not been idle! I must compliment all Committee members for the remarkable energy and dedication they have shown. It really is great to have complete confidence in the enthusiasm and drive which has been so evident in their actions. Attendance and participation at meetings has been excellent.

As most of the news is contained in the various reports, I will concentrate on a matter of great importance to all residents and ratepayers:

### OUR DRINKING WATER



Testing of artillery propellants at Somchem's Dynamic Testing Facility (DTF) over the period 1980 to mid-1995 has resulted in lead being deposited on land at the test site, in the vicinity of the testing equipment. In places, the amount of lead in the soil is in excess of South African guideline limits. Lead is no longer used in tests.

The DTF is located in the catchment area of, and in close proximity to, the Buffels River Dam, which is a source of drink water for townships in the area.

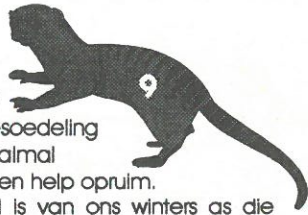
Tests by the CSIR have shown that, at this stage, the aluminium and lead levels of the water in the Buffels River Dam are within Department of Water Affairs and Forestry guidelines for human consumption.

Because of the possible effects on the dam water quality, Somchem has agreed to remove the lead deposits from the DTF land, subject to procedures determined by an independent expert body approved by the above parties. This body is to monitor the removal process, certify that the stipulated removal procedures are followed and certify that the analysis of soil samples, taken from the DTF indicates that no lead deposits which exceed accepted South African standards for soil, remain.

## ROOIELS BOOTKLUB

## RUBBISH BINS

In winter the wooden bins often get filled with residents' domestic refuse, but this is not their intended purpose. They are there for visitors' use and for casual litter collection. It would be most helpful if every householder made an effort to remember to buy one or two rubber bins for their domestic refuse. Drill a hole through the rubber lid handle and you can thread some rope through it and secure it to the two handles on either side of the bin. Wind proof, dog proof, meerkat proof, baboon proof! Margaret and Jo Hensen at Coastal Properties sell these bins.

## SITE CLEARING

The RERA is setting out to clear Rooi-Elis of unwanted alien vegetation in a well-planned and constructive campaign. In the next month or so each owner will receive a letter outlining the plan, in which we will first be attacking the west side of the main tarred road and then, next year, those erven on the east or mountain side of the road. The specific part of the village we are concentrating on is between the beaches and the road along the north boundary of the Reserve - called Study Road if you can believe it. There are a dozen or so badly overgrown erven and then another thirty or so that need clearing - we will list these erf numbers so that the owners can respond as requested. We hope for co-operation so that we can achieve this long sought after target, as we are, after all, in the heart of a famous flora area where aliens have no place at all.

The sediment in the Buffels River Dam near the DTF are being examined to ensure they do not contain excessive lead levels. If necessary, this will be dealt with in the same manner as specified with regards to the soil contamination explained above.

The monitoring of the water for lead and other toxic substances as specified by the parties concerned, by the CSIR and of soil samples by the Agricultural Research Council will continue at frequent intervals, at places agreed to by all the parties concerned.

Further action by the concerned parties will be dictated by the results of the following processes:

- the removal of soil containing excessive lead deposits according to stipulated procedures,
- the determination of lead levels in the sediment in the Buffels River Dam and its removal should this prove necessary, and
- the monitoring of the water quality in the dam in the manner described above.

Somchem undertakes to cease all tests immediately should its activities pollute the water in such a manner as to take it less suitable for human consumption.

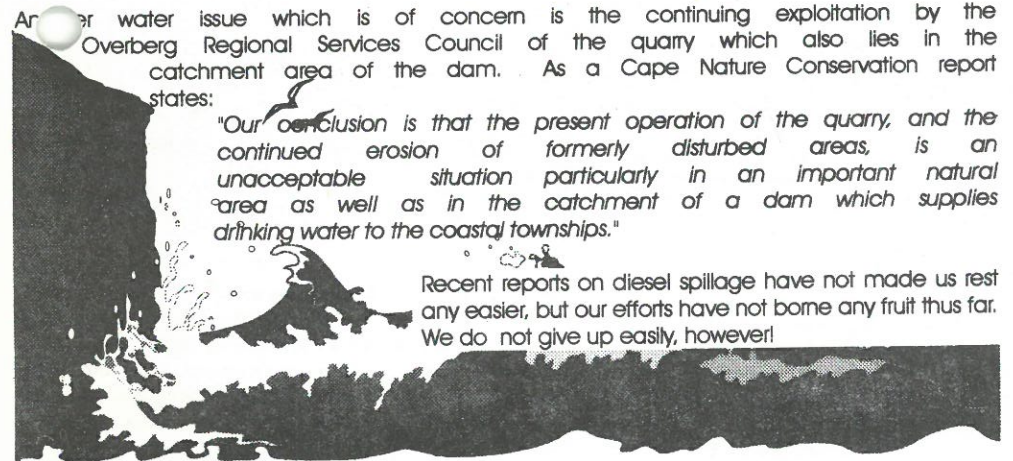
The company has also undertaken to move from the area as soon as they have established an alternative site, which they anticipate will occur before the end of 1999.

Somchem has undertaken to clean up the DTF area before their departure and have given the assurance that they will rehabilitate it as well and will not leave unacceptable levels of pollutants behind. A rocket motor testing facility adjacent to DTF has already been demolished by Somchem, who is in the process of rehabilitating the disturbed area.

Another water issue which is of concern is the continuing exploitation by the Overberg Regional Services Council of the quarry which also lies in the catchment area of the dam. As a Cape Nature Conservation report states:

"Our conclusion is that the present operation of the quarry, and the continued erosion of formerly disturbed areas, is an unacceptable situation particularly in an important natural area as well as in the catchment of a dam which supplies drinking water to the coastal townships."

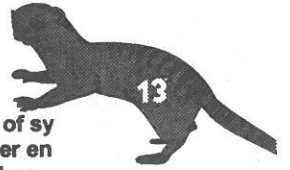

## OTTERS

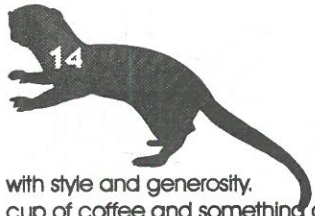
HACK NEWS

After each hack a different family hosts refreshments, always with style and generosity. It is good, (after some hard work), to sit and chat over a beer or cup of coffee and something good to eat and to enjoy a different part of our beautiful Rooi-Els.

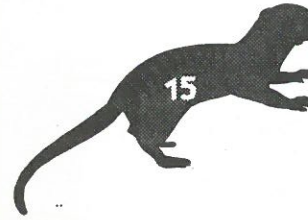
## FIRE HYDRANTS

## BIRD CHAT



Do you realise that there are 142 bird species at Rooi-Els (from the river bridge to the line of the old tip to the coastline). The list has been compiled over ten years and it grows every year. Also, nests have been recorded for most of the permanent residents and ownership is fiercely contested! Why not record your own list while you are here on a monthly basis (or weekly, if you are only here for a short time)? You could then hand these in on an annual basis. For compilation, please use Robert's Birds of Southern Africa classification numbers but for reference there are several "easy to identify" books including Sasol Birds of Southern Africa, Newman's Birds of Southern Africa and Ian Sinclair's Field Guide to the Birds of Southern Africa.



For the beginners (or never-bothered-before types) start with identification of the always present ones

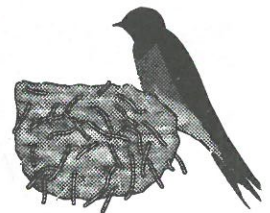
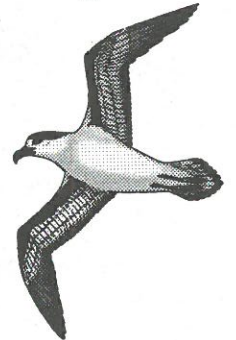

## VOER VAN BOBBEJANE



Die Rooiels Belastingbetalersvereniging het onlangs uit verskeie oorde klagtes ontvang dat inwoners van Rooiels bobbejane voer.

Die voer van bobbejane word uitdruklik deur wetgewing verbied. Nie alleen kan 'n persoon 'n swaar boete opgelê word nie, die howe kan ook direkte gevangenisstraf gelas.

Alhoewel dit nie ons uitgangspunt is om belastingbetalers voor die voel te gaan verkla by die gereg nie, sal dit wel as laaste uitweg oorweeg word. Hierdie vereniging staan hom ten doel om die unieke karakter van Rooiels uit te bou en te behou.

Alle wilde inheemse diere en plante volvoer 'n belangrike funksie en plek in ons unieke kus. Indien wilde diere, byvoorbeeld bobbejane deur mense gevoer word, word hulle hele gedragpatroon en habitat nadelig beïnvloed. Dit skep byvoorbeeld die gevaar dat die wilde diere hulle vrees vir die mens verloor en 'n gevaarlike oortras word.

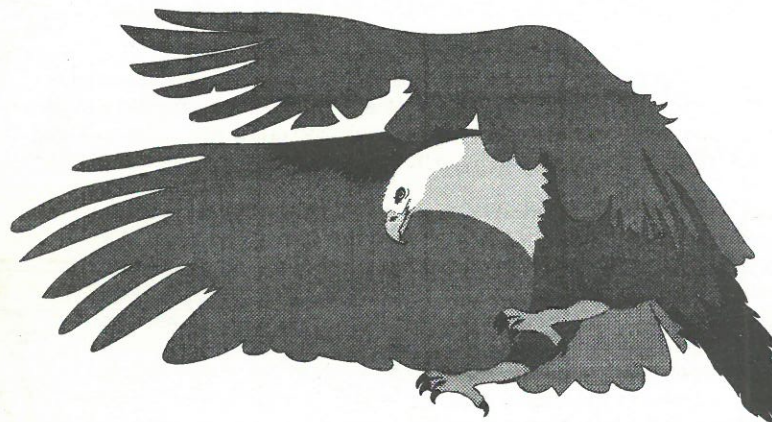
In hierdie verband word daarop gewys dat die plaaslike natuurbewaringsbeamppte verskeie bobbejane moes skiet en doodmaak, waar hulle 'n oortras of lewensgevaar geword het vir die inwoners van Rooiels. Die doodmaak van die bobbejane, spruit direk voort uit die feit dat die diere deur mense gevoer word.

## ONS ADELLIKE BESOEKERS: WITKRUISARENDE



Dis weer sulke tyd. Elke jaar in Julie is ons manjifieke arendpaar lankal doenig by hul taknes teen die Suidkranse van Klein-Hangklip.

Van die twee elers wat 45 dae tevore gelê is, het die eerste kuiken 'n driedag-voorsprong gehad. Dié eerste kuiken, of die ma, het die tweede kuiken verorber.

Twee, drie dassies moet nou elke dag gevang word. So nie, akkedisse, muise, seevoëls, selfs bobbejaantjies. Ma voer verkieslik self. In spysvertering word tot die dassievel afgewurg. Oor die byna drie maande in die nes sal die kuiken by geleentheid doelbewus oorvoer word en 'n regmakertjie van groenblare kon verwag. Eers na ses weke skeur die jong bek self die vleis.

Pa beskerm saam die gebied en dra ook kos aan uit die 30 vierkante kilometer waar die arendpaar saam jag. G'n skarrelende dassie is sy lewe veilig nie, die arende gewaar hom al 'n kilometer ver van bo af.

Alle dinge kan verkeerd loop vir die kleintjie. Bobbejane kan 'n bedreiging wees, of ander roofvoëls, of die wind, of selfs lulse. Ná die brand wat die kop op 11 Desember 1993 gestroop het, is 'n tweede (huidige) nes gebou 'n entjie van die oue. Hulle dra stokke in die poot aan.

Wat 'n gesig! Nes Moses sê in Deuteronomium 32 (lees die ou vertaling) ondersteun die arend met sy twee meter-vierkante die jong voël deur hom net vir 'n oogwink te lig in vlug. Die tyd van trippel op 'n tak in die nes terwyl die vierke klap maar verniet of iets gebeur, is nou vergete. Stadig leer hy die warm lugstrome gebruik. Teen hierdie tyd is hy al yslik groot, maar gaan drie jaar neem om die kenmerkende swart kleed en die wit kruis te wys.

Hoe bevoorreg is ons nie om hierdie bedreigde spesie te kan sien nie, al is dit soms net 'n spikkel hoog bo die kop. Hou veral dop teen November, Desember vir die drie koninklikes van die lug. Ons het walvisse, otters, duikertjies, luiperds en selfs fynbos om van flou te word. Wat nog! Soek 'n mens majesteit, dan is daar witkruisarende.
