**INVITATION FOR PUBLIC COMMENT: DRAFT ESTUARINE MANAGEMENT  
PLANS**

I, Pieter Sybrand van Zyl, Head of the Department of Environmental Affairs and Development Planning in the Western Cape (DEA&DP), in terms of section 34(1)(a), read with section 53(1)(c), of the National Environmental Management: Integrated Coastal Management Act, 2008 (Act 24 of 2008) (the Act), invite members of the public to submit written representations or objections on the draft estuarine management plans (EMPs) set out in the Schedule.

Section 5(1) of the National Estuarine Management Protocol, 2021 (the NEMP), provides that, where an estuary falls within the boundary of a municipality, the provincial environmental department must develop an EMP in consultation with affected municipalities and the relevant national government departments. DEA&DP has ensured that the draft EMPs and the process by which they are developed are consistent with the NEMP as well as with the national coastal management programme, provincial coastal management programme and applicable municipal coastal management programmes, as required by section 34(1)(b)(i) and (ii) of the Act. The draft EMPs have also been developed in compliance with the minimum requirements contemplated in section 6, and the procedure contemplated in section 7, of the NEMP.

After representations and objections from the public have been considered, the draft EMPs will be finalised and submitted to the Provincial Minister responsible for environmental affairs for approval, in compliance with section 9.1(1)(a) of the NEMP. In terms of section 10 of the NEMP, all approved EMPs will be subject to review at least every five years.

Coastal planning schemes must be consistent with approved EMPs (section 56(2)(b)(iv) of the Act), and they must be incorporated into the provincial coastal management programme (section 9.2(2) of the NEMP). Approved EMPs must be taken into account when applications for environmental authorisations, general discharge authorisations and coastal waters discharge permits are considered (sections 63(1)(d) and 69(7)(c) of the Act). The regulation of certain recreational activities will be guided by the intended Draft Spatial Zonation Plans described in the draft EMPs, municipal by-laws or other legislation.

Ek, Pieter Sybrand van Zyl, Hoof van die Departement van Omgewingsake en Ontwikkelingsbeplanning in die Wes-Kaap (DEA&DP), ingevolge artikel 34(1)(a), saamgelees met artikel 53(1)(c), van die “National Environmental Management: Integrated Coastal Management Act, 2008” (Wet 24 van 2008) (die Wet), nooi lede van die publiek om skriftelike verhoë of besware in te dien oor die konsepriviermondingbestuursplanne (EMP’s) uiteengesit in die Bylae.

Artikel 5(1) van die “National Estuarine Management Protocol, 2021” (die NEMP), bepaal dat, waar ’n riviermonding binne die grens van ’n munisipaliteit val, die provinsiale omgewingsdepartement ’n EMP in oorleg met geraakte munisipaliteite en die betrokke nasionale staatsdepartemente moet opstel.
